**T'Railway Loop:** engineering drawings have been drafted and various technical aspects are currently being discussed with project engineers. The BIA Board of Management walked the route on August 9 to gain a visual perspective on project logistics. Construction is anticipated to begin between Dawsons Run and Tobins Road in the coming months. This exciting project will complete the first loop at Tobins Road, with subsequent loops to be completed at the junctions of Anchorage Road and Country Path Road in the future.

**Harbour Plaza Development Plan:** A draft final is expected for review in September.

**Transportation Subcommittee:** discussion took place to establish the next steps for setting a meeting with the Department of Transportation and Works and to draft a meeting agenda. It is anticipated that a meeting with the province will be set for September.

The Conception Bay South Main Street Business Improvement Area Regulation was adopted by Council on December 16, 2014. A levy of 10% of a business' assessed business tax is applied to businesses operating within the Business Improvement Area (BIA).

Conception Bay South's
Main Street district,
which encompasses the
region between the
Manuels River bridge,
up to (but not including)
Terminal Road, and the
area between the
T'Railway to the south
and the coastline in the
north.

The Board also seeks to advance the goals and objectives set out in the Main Street Improvement Plan, which it refined during its Strategic Planning Session in April 2015.

The Plan recommends strategies to improve Main Street branding, the pedestrian realm, wayfinding and signage, vehicular circulation, streetscaping, development character, and business organization.
